3 School districts are divided into subdistricts as set out in Schedule A.

(a.1) in the case of a local government incorporated or continued in a regulation under the *Local Governance Act*, the name identified in that regulation, and

(c) in all other cases, the community names identified in the assignment of civic addresses under the *Emergency 911 Act* and the regulations under that Act.
